Taxable Income Eligible for Qualified Dividend Income (QDI)

For the 2021 tax year, 13.97% of the dividends reported as taxable income to each shareholder on their 1099-DIV are eligible for Qualified Dividend Income (QDI) treatment. As a result, a portion of your ordinary income dividend may be taxed at a reduced capital gains rate rather than the higher marginal rates applicable to ordinary income. To treat a dividend as qualifying for lower rates, you must have held your shares on which you received the dividend for at least 61 days during the 121-day period beginning 60 days before the ex-dividend date of the distribution.
